**Acute toxicity** This product is expected to be of low acute toxicity. Under normal conditions of use, adverse health effects are not anticipated.

**Skin** Not classified as a skin irritant. Contact may result in mechanical irritation.

**Sensitisation** Not classified as causing skin or respiratory sensitisation.

**Mutagenicity** No evidence of mutagenic effects.

**Carcinogenicity** Not classified as a carcinogen. Crystalline silica is classified as carcinogenic to humans (IARC Group 1). However, adverse health effects are not anticipated given the non respirable nature of the silica quartz in this product (as supplied). Contains bifenthrin, which is suspected of causing cancer, at levels below that required for classification.

**Reproductive** No relevant or reliable studies were identified.

**STOT - single exposure** Not classified as causing organ damage from single exposure.

**STOT - repeated exposure** This product contains crystalline silica (quartz) in a non-respirable form. Inhalation of crystalline silica is unlikely to occur from exposure to this product. However, if granules are pulverized or crushed into a fine, respirable powder, silica exposure via inhalation is probable. Repeated overexposure to crystalline silica for extended periods has caused acute silicosis.

### Additional information
