Section 4 - First Aid Measures

Skin Contact: Gently brush away excess particles. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 5 minutes or until removed.

Eye Contact: Quickly and gently brush particles from eyes. Flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

Section 6 - Accidental Release Measures

Accidental release: For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services. This material may be suitable for approved landfill.

Section 7 - Handling and Storage

Handling: Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

Storage: Store in cool, dry area removed from foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Store away from farm chemicals e.g. insecticides, fungicides and herbicides.

Section 8 - Exposure Controls and Personal Protection

Exposure limits have not been set by SWA for other ingredients in product. The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. There is a blanket limit of 10mg/m³ for dusts or mists when limits have not otherwise been established. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly. Section 12 - Ecological Information

Birds: B.t. is not toxic to birds. It biodegrades and does not persist in the digestive systems of birds. The LD50 for bobwhite quail was greater than 10,000 mg of B.t. per kg body weight.

Fish: B.t. has not been reported as having harmful effects in fish. A small marine fish (*Anguilla Anguilla*) was not negatively affected by exposure to 1,000-2,000 times the level of B.t. expected during spray programs. Field observations of populations of brook trout, common white suckers and smallmouth bass did not reveal adverse effects one month after aerial application of the B.t. formulation

Earthworms: No data available.

Other non-target species: Treatment of honeycombs with B.t. var. aizawai will not have a detrimental effect upon bees, nor on the honey produced. Normal exposure rates do not cause harm to honey bees. This product is unlikely to adversely affect the environment due to its organic nature.. Not expected to be an environmental hazard.
